THIS IS AN AGREEMENT, entered into by and between Auburn Enlarged City School District Teachers Association (the "Association") and the Auburn Enlarged City School District.

WHEREAS, the Auburn Enlarged City School District and the Association have discussed the public health need to have instructional staff receive the COVID-19 vaccine; and

NOW, THEREFORE, in consideration of the mutual undertakings and covenants herein contained, the parties stipulate and agree as follows:

- 1. The Auburn Enlarged City School District agrees to allow instructional staff to obtain COVID-19 vaccinations without charging paid leave time and without a reduction in the instructional staff member's regular daily salary or wage.
- 2. Instructional staff are expected to make vaccination appointments at the beginning or end of the regular workday to minimize disruption to the educational process. Time away from work will be limited to the amount of time needed to travel to the vaccination site, receive the vaccination and to return to the instructional staff member's work location
- 3. No provision or provisions of this Agreement may be added to, deleted or modified in any manner unless in writing signed by all the parties hereto.
- 4. The parties hereby acknowledge that they had the opportunity to be advised by counsel or a labor relations specialist concerning this Agreement, that they have read this Agreement, that they fully understand its contents, and that they have executed the same and made the agreements provided for herein voluntarily and of their own free will.
- 5. This Agreement and the terms and conditions contained herein shall not be used by any party to establish a practice, past practice or precedent.
- 6. This Agreement shall sunset and fully expire on June 30, 2021.
