WHEREAS, the Board of Education has determined that it is in the best interest of the District to reject the said Mechanical Construction work bids and re-bid the work under multiple contracts;

NOW, THEREFORE, the Board of Education hereby accepts the recommendations of the Project Architect and the Project Construction Manager and hereby rejects the bids submitted by DW & Crew Mechanicals and Siracusa Mechanical in connection with the project Mechanical Construction work:
