HERNANDEZ moved That the Board of Education advertised in the newspaper and posted on the AECSD website and social media a nomination period from April 14, 2021 to May 5, 2021 for the consideration of renaming Auburn High School. The nomination period also allowed community members to express an interest to participate in a panel. The Board of Education Strategic Planning Committee selected individuals to participate on the panel from various parent, student, teacher, and community stakeholder groups. The panel will review nominations, survey results, and information about the consideration of renaming Auburn High School in order to make a recommendation to the Board of Education prior to the end of the 2020-21 school year. The panel will be expected to adhere to the rules of decorum set forth by the Superintendent.
