



#### Water Filtration STEAM Project at Casey Park

Our 3rd Grade class has finished Module 4 which focuses on the importance of clean freshwater around the world. We have been reading the anchor text "One Well: The Story of Water on Earth" to help build background knowledge, identify the different needs, and deepen our understanding of the overall dependence on Earth's limited water supply.

This discussion also included the important work of Farmer Tanto (visiting author) and the importance of his work in building wells and providing fresh drinking water for many families that don't readily have access to water. Students were introduced to the concept of water pollution (what it is, how it happens, and how it spreads) and the need to treat and filter water properly. So the class decided to extend their knowledge and build a water filtration system.



The class was divided into teams and given the real-world problem to solve - "How can we combine our creativity of the engineering design process to build a water filter that uses our knowledge of groundwater and filtering materials to clean "contaminated" water?" Each team member was given a job title to play:

<u>Lead Engineer/Team Captain</u> (listens to all ideas, decides which materials will be used, gathers the materials needed, oversees the design process and; makes sure everyone is doing their job)

<u>Civil Engineer/Designer</u> (to write out the steps for each material used)

**<u>Budget Director</u>** (to calculate how much money is being spent on the materials needed)

**Environmental Engineer** (to layer the materials in the filter as told by the Designer)





Each student had a job requirement to fulfill and had a voice in how to build and what materials to use. This project lead to some interesting questions such as "I thought our water filter was going to filter out dirty"

water better" and "The water looks clean but would it be safe enough for a family to use".

It continues to be an open-ended project and the students enjoyed using their creativity and the opportunity to work together.

#### **Boys and Girls Track & Field:**



Baseball: The team finished with a league record of 10-4 and an overall record of 14-7 to be the 2019 SCAC Empire Division Champions. The team qualified for sectionals and defeated Cortland in the first round before falling to Jamesville-Dewitt in the semi-finals. First team SCAC honors were earned by Jacob Sanders, Ryan Birchard, Mark Locastro and Brendan Williams. Second team SCAC honors went to Jacob Coleman, and Ryan Stewart and Austin Black received Honorable Mention recognition. The team also earned the distinction of being a NYS Scholar Athlete Team.







Boys Lacrosse: The team finished the season with an overall record of 10-8 and a league record of 8-4 to take 3rd place in the SCAC Empire Division. The team qualified for the

Section III Tournament, beating Watertown 8-3 in the semi-finals and advancing to the Class B Sectional Finals at CNS where they lost to FM 13-4.



Girls Lacrosse: The team finished the year with a League record of 12-2, to earn 2<sup>nd</sup> place in the SCAC Empire Division, and an overall 14-4 record. They qualified for the Section III

Tournament and defeated Central Square in the semi-finals 19-6 before falling to F-M 16-8 in the Championship game. #### PESTICIDE NOTIFICATION

Dear Parent, Guardian, and School Staff:

New York State Education Law Section 409-H, effective July 1, 2001, requires all public and nonpublic elementary and secondary schools to provide written notification to all persons in parental relation, faculty, and staff regarding the potential use of pesticides periodically throughout the school year.

As a reminder, the Auburn Enlarged City School District is required to maintain a list of persons in parental relation, faculty, and staff who wish to receive 48-hour prior written notification of certain pesticide applications. The following pesticide applications are <u>not</u> subject to prior notification requirements:

- \* a school remains unoccupied for a continuous 72-hours following an application;
- \* Anti-microbial products:
- \* nonvolatile rodenticides in tamper resistant bait stations in areas inaccessible to children;
- \* nonvolatile insecticidal baits in tamper resistant bait stations in areas inaccessible to children;
- \* silica gels and other nonvolatile ready-to-use pastes, foams, or gels in areas inaccessible to children;
- \* boric acid and disodium octaborate tetrahydrate;
- \* the application of EPA designated biopesticides;
- \* the application of EPA designated exempt materials under 40CFR152.25;
- \* the use of aerosol products with a directed spray in containers of 18 fluid ounces or less when used to protect individuals from an imminent threat from stinging and biting insects including venomous spiders, bees, wasps, and hornets.

If there is an emergency application necessary to protect against an imminent threat to human health, a good faith effort will be made to supply written notification to those on the 48-hour prior notification list.

If you have not yet registered to receive 48-hour prior notification of pesticide applications that are scheduled to occur in your school, please complete the form below and return it to the Buildings & Grounds office Auburn Enlarged City School District pesticide representative, Larry Garuccio, at 78 Thornton Avenue, Auburn, NY 13021.

#### BMI Notification for 2019 - 2020 School Year

As part of a required school health examination, a student is weighed and his/her height is measured. These numbers are used to figure out the student's body mass index, or "BMI." The BMI helps the doctor or nurse know if the student's weight is in a healthy range or is too high or too low. Recent changes to the New York State Education Law require that BMI and weight status group be included as part of the student's school health examination. A sample of school districts will be selected to be part of the survey; we will be reporting to New York State Department of Health information about our students' weight status groups. Only summary information is sent. No names and no information about individual students are sent. However, you may choose to have your child's information excluded from this survey report.

The information sent to the New York State Department of Health will help health officials develop programs that make it easier for children to be healthier.
