Regular Board of Education Meeting, Tuesday, March 26, 2019 RESOLVED: THAT THE BOARD OF EDUCATION, ON THE RECOMMENDATION OF THE SUPERINTENDENT OF SCHOOLS HEREBY APPROVES THE FOLLOWING RESOLUTION:

BE IT RESOLVED by the Board of Education of the City School District of the City of Auburn, Cayuga County, New York, as follows:

<u>Section 1</u>: The annual election of members of the Board of Education shall be held in the City School District of the City of Auburn, Cayuga County, New York, on May 21, 2019, for the purpose of voting on candidates to fill three (3) full terms of three (3) years each, commencing on July 1, 2019 and expiring on June 30, 2022. The candidate receiving the largest number of votes, the candidate receiving the second highest number of votes, and the candidate receiving the third highest number of votes shall be entitled to a full three (3) year term on the Board of Education commencing on July 1, 2019 and expiring on June 30, 2022.

<u>Section 2</u>: The annual meeting for the purpose of voting upon a school district budget for the City School District of the City of Auburn, Cayuga County, New York, shall be held on Tuesday, May 21, 2019, at the same time and at the same places within the said School District as the annual election of members of the Board of Education of said School District.

<u>Section 3</u>: The polls for such annual election and budget vote shall be open from 7:00 a.m. until 9:00 p.m., prevailing time, at the voting places designated by the Board of Education for each of the school election districts of the School District, which have been established by the Board of Education.
