MICHELE RIVOLI, OF 6 ALDRICH AVE., DISCUSSED POLICIES AND OPEN MEETING LAWS AS WELL AS WHAT A WASTE OF TIME THIS WAS FOR THE BOARD TO ATTEMPT TO CHANGE THE NAME OF THE AUBURN HIGH SCHOOL WITHOUT BEING ORGANIZED BEFORE BEGINNING THE PROCESS. LAUREL ULLYETTE, OF FRANKLIN STREET, SPOKE ON BEHALF OF MELINA CARNICELLI OF 88 BURTIS POINT, WHO WANTED TO ADVOCATE FOR THE NAME OF THE HIGH SCHOOL TO BE CHANGED TO HARRIET TUBMAN HIGH SCHOOL AS TO HONOR HARRIET'S LEGACIES AND ACHIEVEMENTS. DENNIS BANEY STATED ANYTHING AS BIG AS A NAME CHANGE FOR THE HIGH SCHOOL SHOULD GO OUT TO THE COMMUNITY FOR A VOTE. HE ALSO STATED THAT THERE IS NO PLACE FOR POLITICS IN THE SCHOOL SYSTEM OR ON THE BOARD OF EDUCATION. ARLENE RYAN, OF 36 ORCHARD ST., CAME OUT TO OPPOSE THE NAME CHANGE FOR AUBURN HIGH SCHOOL. ELIZABETH CUDDY, OF 119 STRYKER AVE., IS OPPOSED TO THE NAME CHANGE AS WELL. SHE STATED THIS HAS NOTHING TO DO WITH RACE; PEOPLE SIMPLY WANT TO KEEP THE CURRENT NAME AND THIS SHOULD BE ON A BALLOT VOTE, IF IT COMES UP AGAIN, FOR THE WHOLE COMMUNITY TO PARTICIPATE IN.
