MR. ANDRE MOVED WHEREAS, AUBURN ENLARGED CITY SCHOOL DISTRICT ("LESSEE") IS A POLITICAL SUBDIVISION DULY ORGANIZED AND EXISTING PURSUANT TO THE CONSTITUTION AND LAWS OF THE STATE OF NEW YORK; AND

WHEREAS, LESSEE IS DULY AUTHORIZED BY APPLICABLE LAW TO ACQUIRE SUCH ITEMS OF PERSONAL PROPERTY AS ARE NEEDED TO CARRY OUT ITS GOVERNMENTAL FUNCTIONS AND TO ACQUIRE SUCH PERSONAL PROPERTY BY ENTERING INTO LEASE-PURCHASE AGREEMENTS; AND

WHEREAS, LESSEE HEREBY FINDS AND DETERMINES THAT THE EXECUTION OF A LEASE FOR THE PURPOSE OF LEASING WITH THE OPTION TO PURCHASE THE PROPERTY DESIGNATED AND SET FORTH IN ATTACHMENT 2 TO THE LEASE IS APPROPRIATE AND NECESSARY TO THE FUNCTION AND OPERATIONS OF THE LESSEE; AND

WHEREAS, TCF EQUIPMENT FINANCE, A DIVISION OF TCF NATIONAL BANK ("LESSOR") SHALL ACT AS LESSOR UNDER SAID LEASE; AND

WHEREAS, THE LEASE SHALL NOT CONSTITUTE A GENERAL OBLIGATION INDEBTEDNESS OF THE LESSEE WITHIN THE MEANING OF THE CONSTITUTION AND LAWS OF THE STATE;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE AUBURN ENLARGED CITY SCHOOL DISTRICT:

SECTION 1. THE LEASE, IN SUBSTANTIALLY THE FORM AS PRESENTLY BEFORE THE BOARD OF EDUCATION OF THE LESSEE, IS HEREBY APPROVED, Regular Board of Education Meeting, Tuesday September 11, 2018 AND THE SUPERINTENDENT OF SCHOOLS OF THE LESSEE IS HEREBY AUTHORIZED TO NEGOTIATE, ENTER INTO, EXECUTE AND DELIVER THE LEASE AND RELATED DOCUMENTS IN SUBSTANTIALLY THE FORM AS PRESENTLY BEFORE THE BOARD OF EDUCATION OF THE LESSEE, WITH SUCH CHANGES THEREIN AS SHALL BE APPROVED BY SUCH OFFICER, AND WHICH LEASE WILL BE AVAILABLE FOR PUBLIC INSPECTION AT THE OFFICES OF THE LESSEE.

SECTION 2. THE LESSEE SHALL, AND THE OFFICERS, AGENTS AND EMPLOYEES OF THE LESSEE ARE HEREBY AUTHORIZED AND DIRECTED TO TAKE SUCH FURTHER ACTION AND EXECUTE SUCH OTHER DOCUMENTS, CERTIFICATES AND INSTRUMENTS AS MAY BE NECESSARY OR DESIRABLE TO CARRY OUT AND COMPLY WITH THE INTENT OF THIS RESOLUTION, AND TO CARRY OUT, COMPLY WITH AND PERFORM THE DUTIES OF THE LESSEE WITH RESPECT TO THE LEASE.

<u>SECTION 3</u>. THE LESSEE'S OBLIGATIONS UNDER THE LEASE SHALL BE EXPRESSLY SUBJECT TO ANNUAL APPROPRIATION BY LESSEE; AND SUCH OBLIGATIONS UNDER LEASE SHALL NOT CONSTITUTE A GENERAL OBLIGATION OF LESSEE OR INDEBTEDNESS OF LESSEE WITHIN THE MEANING OF THE CONSTITUTION AND LAWS OF THE STATE OF NEW YORK.

SECTION 4. ALL OTHER RELATED CONTRACTS AND AGREEMENTS NECESSARY AND INCIDENTAL TO THE LEASE ARE HEREBY AUTHORIZED, RATIFIED AND APPROVED.

SECTION 5. LESSEE REASONABLY ANTICIPATES TO ISSUE NOT MORE THAN \$10,000,000 OF TAX-EXEMPT OBLIGATIONS (OTHER THAN "PRIVATE ACTIVITY BONDS" WHICH ARE NOT "QUALIFIED 501(C)(3) BONDS") DURING THE CURRENT CALENDAR YEAR AND HEREBY DESIGNATES THE LEASE AS A "QUALIFIED TAX-EXEMPT OBLIGATION" FOR PURPOSES OF SECTION 265(B) OF THE INTERNAL REVENUE CODE OF 196, AS AMENDED.

NOW, THEREFORE, it is RESOLVED, that the Board of Education of the Auburn Enlarged City School District agrees to enter into a

contract with the OCM BOCES for the provision of said services to the District and not to exceed in total over the life of this agreement the annual amount of \$92,530 and associated CNYRIC charges with such amount to include annual OCM BOCES support costs and applicable taxes and surcharges, and with such support costs and applicable taxes and surcharges included at the current rate and subject to change as established in the OCM BOCES budget or mandated by any federal, state or local authority. This amount may be amended with the approval of both parties. The District will be liable to OCM BOCES for early cancellation or withdrawal from this agreement to the same extent that OCM BOCES is liable to any vendor(s) of these services, including liability for applicable penalties or liquidated damages, and the District will also be liable for costs and expenses, including reasonable attorneys' fees and disbursements, incurred by OCM BOCES as consequence of any such early cancellation or withdrawal. Payment will be made as part of a regular annual OCM BOCES contract for services. Further, this agreement is subject to the approval of the Board of Education of OCM BOCES. This contract will be for a maximum period of four years commencing on or about July 1, 2018, and continue through June 30, 2022.
