ELIZABETH CUDDY OF 119 STRYKER AVE., SPOKE ABOUT HER CONCERNS WITH THE CURRENT SCHOOL BOARD MEMBERS. CINDY BANEY OF FLEMING, SPOKE ABOUT HOW SHE WAS RAISED WITH STRONG VALUES AND THAT HARD WORK MATTERS - SKIN COLOR SHOULD NOT MATTER. DENNIS BANEY OF FLEMING, DISCUSSED THE TOPIC OF RENAMING THE HIGH SCHOOL AND STATED "PUTTING THIS ON HOLD IS NOT THE ANSWER". HE ASKS THAT THE BOARD PUT AN END TO THE TOPIC FOR GOOD. JASON MYERS OF AUBURN, ASKED NOT TO BE CUT OFF AFTER 3 MINUTES AND TOLD THE DISTRICT CLERK HE WOULD NOT COMPLY WITH THAT DIRECTIVE. HE WENT ON TO DISCUSS THE DISCIPLINE HANDED DOWN FOR A FIGHT IN THE SCHOOLS A WEEK PRIOR AND HOW HE DID NOT AGREE WITH THE WAY IT WAS HANDLED.
