

MESSAGE FROM THE SUPERINTENDENT

Dear Community Members,

We are pleased to share the Auburn Enlarged City School District's proposed 2025–2026 school year budget. Our Board of Education and district administrators have worked thoughtfully and diligently to craft a budget that continues to support high-quality instruction and programs tailored to the diverse needs of our students, while remaining mindful of the financial challenges facing our community.

The proposed budget totals \$107,323,677, an increase of 2.8% from the previous year. This budget includes the addition of 11.5 critical instructional positions—3 Special Education teachers, 3 Teacher Assistants, 5 Teacher Aides, and a part-time Music Teacher. We will continue summer school, which was previously funded through temporary grants. By incorporating these positions into our regular budget, we aim to reduce achievement gaps, support student wellness, and maintain smaller class sizes that promote effective learning.

With the approval of the 24-25 budget, the District created a music production room at Auburn High School. This program introduced a music production course where students can write, compose, and record their own music—an innovative opportunity supporting creativity and engagement. The response to this addition was overwhelmingly positive, and the need for an additional part-time teacher to expand the program to a level 2 course to continue to grow our students' knowledge and expertise is included in the 25-26 budget.

New York State is proposing a net total increase of 1% in State Aid, which still leaves us with a shortfall. To close the budget gap responsibly, we will use \$2 million from our fund balance and an additional \$500,000 from tax certiorari reserves. In 2023-2024, we used similar reserves to implement a districtwide safety notification system, for which we were reimbursed approximately 80% through state aid.

The proposed budget includes a modest 3.25% increase in the tax levy, well below the state tax cap of 3.78%. A home assessed at \$100,000 translates to an estimated annual increase of \$80, or \$6.70 per month.

2024-25 ACCOMPLISHMENTS

- 1. **The Auburn grade level and department teams** have continued to utilize a data analysis process to reflect on data-driven instructional practices in an effort to utilize this knowledge to enhance student achievement and engagement. The departments have also worked on specific department focused curricular items while collaborating with one another to strengthen core instruction in all areas.
- 2. Some teachers in grades K-5 are participating in **two ELA program pilots** in an effort to select a new ELA program consistent for grades K-5 that is aligned to the science or reading and supports evidence-based instructional practices.
- 3. Teachers in grades 6-8 are also piloting a resource in an effort to **update their ELA curriculum** to ensure alignment to the Next Generation Learning Standards and meeting individual student needs.
- 4. Teachers in grades K-12 are working on a project to develop math learning targets that are vertically aligned in order to align instruction to **the Next Generation Learning Standards**, embed evidence-based instructional practices that support higher student achievement and improve the overall coherence of math instruction across all grade levels.
- 5. During the 2024-2025 school year, PreK teachers gained insight into impactful classroom practices through **monthly professional development.**
 - a. Each monthly faculty meeting focused on **evidence-based practices (EBP)**. Evidence-based practices are educational practices or interventions that are backed by strong evidence of their effectiveness as demonstrated by scientifically based research. EBP include: maximizing classroom structures and routines, modeling positive behavior and building relationships, student engagement, positive reinforcement, and managing challenging behaviors.
 - b. Auburn PreK sites focused on **early predictors of reading ability**, particularly phonological and phonemic awareness, letter-sound knowledge, receptive/expressive vocabulary, and oral listening comprehension. In addition to district run professional development, PreK teachers have been able to participate in regional professional development with CO BOCES and surrounding districts through the Early Learning Collaborative Community.
- 6. The Diversity, Equity, and Inclusion **Task Force** met bi-monthly to conduct a continuous assessment of the Diversity, Equity, and Inclusion Plan, as well as made minor revisions to the plan for the 25-26 school year.
- 7. The district held one Parent/Guardian University this school year focused on ELA, Math, SEL, and STEM instruction.
- 8. **The Auburn Librarians** have actively engaged students in Project-Based Learning (PBL) throughout the year, focusing on areas such as Manipulative Engineering, Design/Novel Engineering, Coding/ Computational Thinking, and Circuitry. The goal is for K-6 students to complete three PBL experiences annually. At the secondary level, the librarians have expanded opportunities by incorporating innovative tools and experiences such as 3D printing, use of Cricuit Design space, and sewing.
- 9. **Teacher Technology mentors** provide daily support for the instructional needs of our teachers and support staff. The Teacher Technology Mentors work closely with the Student Technology Mentors to empower them to assist teachers, substitutes, and fellow students.
- 10. **The Auburn IT department** works continuously to maintain day-to-day operations and Chromebook health for our students while also providing technical support, maintaining infrastructure, and implementing new technology to support education.
- 11. **Technology Infrastructure Improvements** This school year, the Information Technology department has made significant enhancements to the district's technology infrastructure to strengthen security, reliability, and overall operational efficiency. Key upgrades included the installation of a full-room uninterruptible power supply (UPS) system in our primary data center, ensuring continuous uptime during power disruptions. We also upgraded our video surveillance storage and access control systems to improve campus safety and monitoring capabilities. In three of our schools, we completed full network switching upgrades to support faster, more reliable connectivity. Additionally, we finalized the implementation of a district-wide lockdown and mass notification system, greatly enhancing our emergency response readiness.



Basic STAR tax savings	\$469

For ALL Owner-occupied Residences:

All taxpayers are eligible for a Basic STAR exemption for owner-occupied, primary residences. For 2025-2026 the STAR program continues to provide qualifying households with a \$30,000 exemption on the full value of their property. For a home with a full value of \$100,000, qualifying residents will realize an estimated \$469 in Basic STAR tax savings.

For Senior Citizens:

The Enhanced STAR program for senior citizens provides eligible seniors an exemption from school property taxes for owner-occupied, primary residences. To be eligible for this exemption, a property owner must be 65 years of age or older on December 31, 2025, with income not exceeding \$107,300.

STAR provides qualifying households with up to a \$86,100 exemption on the full value of their property. Qualifying residents owning a home with a full value of \$100,000 will recognize an estimated \$1,181 in Enhanced STAR tax savings in 2025-2026.

ESTIMATED SCHOOL TAX IMPACT:

Projections for the tax rates on each of the four towns and city comprising the Auburn Enlarged City School District are dependent upon the assessed value of the District, NYS equalization rates for each municipality and the local tax levy amount. Property assessments are still subject to change and equalization rates are not completed by the State until summer.



COMMUNITY COLLABORATIONS

The Auburn School District is fortunate to receive support from a variety of local sources, including businesses and community organizations.

- The District collaborates with Cayuga Community College, Cayuga-Onondaga BOCES, Early Childhood Center, Auburn YMCA, Headstart, Cayuga Seneca Community Action Agency, Montessori School of the Finger Lakes, and John E. Gavras Center to provide Prekindergarten programming for 3 and 4-year-old children in Auburn. These programs prepare our students for a strong academic foundation for when they enter kindergarten.
- The Auburn Education Foundation (AEF) is a major supporter of innovative projects in the District. This past school year, the AEF has supported projects in the area of literacy, social emotional learning, science and technology.
- The school district partners with Cayuga Community College (CCC) and the Manufacturer's Association of Central New York (MACNY) to support the Pathways in Technology Early College High School (P-TECH) program and other opportunities for our students to explore careers in the manufacturing industry.

ABSENTEE VOTING

Qualified school district voters who are unable to vote in person on Tuesday, May 20, 2025, may vote in the Annual School District Election and Budget Vote by absentee ballot. Those who are ill, hospitalized, physically disabled, away on business or vacation, or who are detained in jail, awaiting action by a grand jury, awaiting trial or confined for an offense other than a felony or concerned about exposure to Covid-19 may use an absentee ballot to vote. Registered sex offenders must use an absentee ballot to vote.

To receive an absentee ballot, individuals must first fill out an application for the ballot. If you are unable to personally vote at your polling location, applications are available in the district office and on our website and may be filed up to one day before the date of the vote.

Auburn Junior High School displayed banners in the hallways for Native American Heritage Month.


Auburn High School students participated in the annual World Language Day at Cayuga-Onondaga BOCES.
