## MESSAGE FROM THE SUPERINTENDENT

#### Jeffrey A. Pirozzolo

Dear Community Members,

Our board of education and school district administrators have been working diligently to develop a budget for the 2024-2025 school year that continues to provide high-quality curriculum and instruction that meets the unique needs of our students while keeping in mind the limited resources of the community. The Auburn Enlarged City School District continues to be one of the most fiscally efficient and resourceful districts in the state, spending just \$21,263 per pupil versus the state average of \$26,857 per pupil.

The district's proposed budget expenditures for the 2024-2025 school year are \$104,404,172, which is up 4.1%, or \$4.1 million, from 2023-2024. The proposed budget includes 17 instructional positions that were previously funded with grants including school counselors, social workers, additional AIS math and reading teachers, and additional general education teachers that help keep our class sizes lower. By rolling these 17 positions into the general budget, it will help with student achievement gaps to get all students up to grade level and also continue to provide the social and emotional supports for our students.

The 2024-2025 proposed budget also includes a net increase of 13 staff positions including a special education teacher, 2 teacher assistants, and 10 teacher aides. With the addition of these positions, the district will be able to continue to provide our students with equitable access to educational opportunities and services. In addition, the proposed budget includes funds to build a music production room at Auburn High School allowing us to offer a music production class to students where they can learn to write, compose, and record their own music.

The grant funding received from the American Rescue Plan is coming to an end, but fortunately we will be able to use the remainder of those funds through the upcoming summer to fund our summer school initiatives. Some other major items we have used the funds for are technology devices and infrastructure, enhanced professional development opportunities for our staff, additional AIS reading and math teachers, school counselors, and alternative education programs at the high school and elementary levels, which we will continue to run by building them into the regular budget.

For the 2024-2025 school year, our district will receive no additional foundation aid from New York State, so the district will continue to spend down its fund balance; \$3 million of the district's fund balance will be used to balance the budget this year and \$500,000 in tax reserves and ERS reserves will also be used. With last year's budget, we used \$3 million out of reserves to implement a campus notification system to enhance safety and security in all of our buildings, and we received about 80 percent of the cost back in the form of state aid.

This proposed budget will include a 1.99 percent increase in the total tax levy, which is below the NYS tax cap of 2.86 percent. On a home assessed at \$100,000, the estimated annual tax increase will be \$94, or \$7.84 per month.

#### 2023-24 ACCOMPLISHMENTS

1. The Auburn grade level and department teams have continued to utilize a data analysis process to reflect on data-driven instructional practices in an effort to utilize this knowledge to enhance student achievement and engagement. Each grade level and department has also worked throughout the year to pull their curricular resources into digital shared folders to support cohesion between each group, which supports equitable access to instruction for all students.

2. Grades Kindergarten through 5 implemented an updated version of the math program, Eureka Math Squared, supported by district Math Instructional Coaches, Stefan Kowalski and Nick Musso.

**3.** Teachers representing grades kindergarten through 6 convened several times this year to review Social Studies curricular resources in an effort to ensure relevant and current programming.

4. Auburn PreK sites focused on the important role of play in student learning. 3PK and UPK teachers took part in a monthly book study led by AECSD PreK Coaches around the text "Purposeful Play", by Kristine Mraz, Alison Porcelli, and Cheryl Tyler. In addition to discussion around the text, teachers shared what this looks like in their classrooms and ideas for more intentional play activities for students.

5. This school year, PreK teachers gained insight into impactful classroom practices through monthly professional development. In addition to play, topics included Speech Therapy milestones for preschoolers, led by retired AECSD Speech Pathologist, Ken Sargent; an overview of the NYS Early Literacy briefs, led by CO BOCES Professional Development Specialist, Jodi Burnash; and the importance of self-care for caring adults, by the Gavras Center's Josephine Emilio.

6. The Diversity, Equity, and Inclusion Task Force met bi-monthly to conduct a continuous assessment of the Diversity, Equity, and Inclusion Plan, as well as made minor revisions to the plan for the 24-25 school year. The DEI Task Force in collaboration with community members had input on the My Brother's Community Action Plan that was submitted to the state in March.

7. The district held two Parent/Guardians Universities this school year. Between both of these events, the district focused on ELA, Math, SEL, Special Education, and Media Misinformation.

8. Dr. Reneé Burgess, Executive Director of Diversity, Equity, Inclusion, and Instruction and Jodi Burnash, Curriculum Coordinator from Cayuga-Onondaga BOCES held monthly coaches academies for our twelve instructional coaches in the district. During these academies coaches read and participated in reflective activities on The Art of Coaching, as well focused on coaching cycles with educators.

**9.** The Auburn Innovation Spaces in the elementary building have continued to welcome families in their space at multiple Family Engagement Nights. Activities included using the Cricut Makers, 3-D printing, button making, and coding with robots. The Innovation Spaces in grades K-6 have completed over 80 project based learning activities this school year. Auburn Junior High has been leveraging their innovation space for students during their lunch groups using both the Circuit Makers and 3-D printing. Auburn High School has hosted two Innovation Events. The students were able to make their own ornaments in December using the Cricut Maker, and in March, they were able to design and decorate sketchbooks in conjunction with the guest author. Nearly 100 students participated in each event. We look forward to continuing with these innovative activities in the 2024 -2025 school year.

10. The Auburn IT department has installed and upgraded over 30 network switches to improve security and access. They have also improved the server disaster recovery process, installed new Internet Service Provider district wide (faster speeds/true redundant connectivity), and implemented new cloud based network image deployment and windows patching solution.

11. The Auburn technology mentors have begun a Student Technology Mentor Program. In this program the Technology Mentors trained student volunteers on basic troubleshooting for Chromebooks, Promethean panels and projection needs. The Student Technology Mentors attend to introductory technology needs of other staff members, substitute teachers and their peers. This program involves student volunteers from all buildings between grades 5 - 12.

**12.** In September, the Auburn IT department distributed and has continued to support over 5,000 Chromebooks for students in all grade levels and buildings.


#### Administrative Component 11.27% of Budget



## 2023-24 ATHLETIC HIGHLIGHTS

## Fall Season

- Girls Volleyball clinched the Salt City Athletic Conference (SCAC) Pascale Division Championship, were recognized as a NYS Scholar Athlete Team and Head Coach Kim Doan was named Division Coach of the Year
- The Girls Cross Country Team placed 2nd in the SCAC Metro Division Championship this fall, followed up by a 5th place finish in the Section III Class A Championships, with Ali Pineau placing 4th overall for Auburn.
- The Boys Cross Country Team delivered a memorable fall season, clinching the SCAC Metro Division Championship, securing their 2nd consecutive Section III Class A Championship, followed by a 3rd place team finish, in the NYS X-C Championship meet. Finally, boys team members qualified for and competed in the Nike X-C National Championships in Portland, Oregon.
- Varsity Field Hockey displayed consistency and skill by reaching the championship game of the Cayuga County Field Hockey tournament for the third consecutive year.
- Varsity Football exhibited resilience and determination, finishing the regular season with a 4-4 record, including three consecutive victories and securing a Homecoming weekend win over Henninger.
- Varsity Girls Soccer celebrated eight athletes receiving league postseason honors, recognizing their contributions to the team's success.
- Varsity Girls Tennis once again dominated league play with a flawless 14-0 record, securing another SCAC, Empire Division Championship, and NYS Scholar Athlete Team recognition.
- Varsity Boys Golf concluded the season with an 11-5 record and an impressive 3rd place finish in league play.
- Varsity Boys Soccer laid the foundation for future success in the Class AA soccer landscape, highlighted by Senior - Osvaldo Chum-Domingo, earning SCAC, Central Division, 1st Team honors as goalkeeper.
- The Varsity Cheerleading team contributed to the excitement of the fall season; participating in cheer competitions across CNY. Additionally, they played a crucial role, alongside The Vanguard and drum corps, in the success of Auburn's edition of "Friday Morning Lights" newscast, hosted and televised by WSYR 9 in September of 2023.

## Winter Season

- Winter Varsity Cheerleading team, placed the highest in recent history, in the Section III Winter Team Cheerleading Championships in February.
- Girls Varsity Basketball boasted both individual accomplishments (Peyton Maneri eclipsing the 1000 point milestone) and the Maroons cagers advanced to the Section III Class AA Championship vs. Central Square.
- The Varsity Wrestling team was acknowledged by the Syracuse Wrestling Officials Association (SWOA) as the 2023-24 recipient of John Arcaro Memorial Sportsmanship Award. Individually: Colton Hai (Jr.-215 lbs.) 4th Place, Sec.3 Class A; Brady Maneri (So -101 lbs.) and Mike Boyhan (Jr.-131 lbs.) were crowned Sec.3 Class A Champions. Boyhan placed 3rd in Sec.3 Div. 1, missing a trip to the NYS championship tournament by 1 point. Maneri was crowned Champion of Sec.3 Div. I in the 101 lb. weight class, enroute to a 6th place finish at the NYSPHSAA Wrestling Championships in Albany.
- Varsity Boys Basketball hosted a fundraising basketball tournament in the first week of December to benefit Upstate Golisano Children's Hospital and Upstate Cancer Center, raising nearly \$2k with contributions from the Auburn Basketball Community and the other participating teams.
- The Winter Swim team boasted Riley Fitzgerald (Sr.) posting two 5th place finishes at the Section III Class A Swimming Championships in the 200 and 500 Freestyle, while the Maroons squad had three different relay events place in the top 10.
- Rylee Catalfano, Samantha Catalfano, Finley Hogan and Makenna Komanecky tasted the success of a Section III Championship as members of the Skaneateles Girls Ice Hockey team. They advanced out of the section to participate in the NYS Girls Ice Hockey Final Four weekend.
- Varsity Boys Ice Hockey had a rebound season tallying 4 more victories than the previous season, including a home game sectional playoff victory over Cortland-Homer.
- Varsity Boys and Girls Bowling displayed another one-two punch in league standings. The girls team placed 2nd in the SCAC Empire Division while the boys team posted a nearly perfect 15-1 record enroute to the championship in their division. Eric Barski qualified for the Section III composite team and led the Section III team in the state meet with a 210 average across 6 games.
- Varsity Indoor Track & Field once again had an impressive culmination to the season. The girls team placed 2nd overall at the Section III championships, their highest finish for indoor track & field to date, Sectional champions included Kyleen Brady, Abigail Ringwood, Nora Burroughs and Ali Pineau. The boys squad clinched Auburn's first ever indoor track & field team Sectional Title, champions for the boys included Keegan Brady, Owen Gasper, Chris Howard and Austin Ferrin. Twelve total Maroon's athletes went on to compete in the NYS championships in Staten Island.

## NYS SCHOOL TAX RELIEF PROGRAM (STAR)

#### **Basic STAR Exemption Impact**

## For ALL Owner-occupied Residences:

All taxpayers are eligible for a Basic STAR exemption for owner-occupied, primary residences. For 2024-2025 the STAR program continues to provide qualifying households with a \$28,800 exemption on the full value of their property. For a home with a full value of \$100,000, qualifying residents will realize an estimated \$492 in Basic STAR tax savings.

## For Senior Citizens:

The Enhanced STAR program for senior citizens provides eligible seniors an exemption from school property taxes for owner-occupied, primary residences. To be eligible for this exemption, a property owner must be 65 years of age or older on December 31, 2024, with income not exceeding \$98,700.

STAR provides qualifying households with up to a \$80,640 exemption on the full value of their property. Qualifying residents owning a home with a full value of \$100,000 will recognize an estimated \$1,181 in Enhanced STAR tax savings in 2024-2025.

#### **ESTIMATED SCHOOL TAX IMPACT:**

Projections for the tax rates on each of the four towns and city comprising the Auburn Enlarged City School District are dependent upon the assessed value of the District, NYS equalization rates for each municipality and the local tax levy amount. Property assessments are still subject to change and equalization rates are not completed by the State until summer.


